**SKIN CONFIDENT FACE-TO-FACE SKIN CAMOUFLAGE CONSULTATIONS  
COVID-19 RISK ASSESSMENT**

<b>Hazard/Risk</b>	<b>Mitigating Actions</b>
<b>Spread of COVID-19 from someone who has been in contact with the infection</b>	<p>Practitioner will cancel any appointment, and client will be asked not to attend any appointment whenever:</p> <ul style="list-style-type: none"><li>• They, or anybody within their household, have been diagnosed with COVID-19 within 14 days of their consultation.</li><li>• They, or anybody within their household, have come into contact with any person diagnosed with COVID-19 within 14 days of the consultation (whether they have been contacted through track &amp; trace or find out about it in another way)</li><li>• They, or anybody within their household, develop COVID-19 symptoms within 14 days of the consultation (dry persistent cough, loss of smell or taste, elevated temperature, any other unexplained symptoms they are concerned may be COVID related)</li></ul> <p>→Client consent form to be signed prior to consultation</p>
<b>Spread of COVID-19 to a</b>	Clients who have been asked by the government to shield will be asked not to attend appointments.

<p><b>clinically vulnerable person</b></p>	<p>→ Client consent form to be signed prior to consultation</p>
<p><b>Risk of contagion during the consultation - actions requested of Client</b></p>	<p><u>Client will be asked to:</u></p> <ul style="list-style-type: none"> <li>• wear a face mask, and disposable face masks will be provided by Skin Confident for all clients.</li> <li>• come to consultation alone (unless accompanying vulnerable adult or child, in which case they should be from the same household)</li> <li>• wash hands upon arrival, and to use hand sanitiser as appropriate</li> <li>• keep personal belongings to a minimum</li> </ul> <p>→ Client consent form to be signed prior to consultation</p>
<p><b>Risk of contagion during the consultation - actions by Practitioner</b></p>	<p><u>Practitioner will:</u></p> <ul style="list-style-type: none"> <li>• wear face mask and visor at all times</li> <li>• wear disposable gloves whenever practical/possible, and at all events wash hands before commencing the consultation and again afterwards</li> <li>• avoid unnecessary personal contact with client and their possessions</li> <li>• keep consultation space as free of products as possible, and keep products in wipe-down containers</li> <li>• thoroughly clean and sanitise consultation space and all products and tools between each client</li> <li>• factor in sufficient time between appointments to avoid clients coming into contact with one another</li> <li>• Hand sanitiser will be available in the consultation room and frequent use will be encouraged</li> <li>• Weather permitting, the window will remain open to allow for sufficient ventilation</li> <li>• Use disposable applicators where possible</li> </ul>

<p><b>Risk of contagion in the Lombard Street premises</b></p>	<ul style="list-style-type: none"><li>• Client to be given choice of stairs or elevator, to avoid the confined space of the elevator</li><li>• Client will be asked to arrive on time but no more than 5 minutes in advance of the consultation</li></ul> <p>➔ Information sheet to be made available to client</p> <p>➔ Confirmation from Regus on additional measures in place</p>
